HILLSDALE COUNTY SENIOR CENTER – Samantha Gordon from Perennial Park gave a presentation on the services available to Somerset Seniors. She said 13% of the Somerset population is over 60 years old and 5.6% of the Somerset Township residents live below the poverty level. Gordon passed out literature to the Board of Trustees.

REPORTS

Fire & Rescue — Fire Chief Friess gave the Fire & Rescue report for the month of December, 2021. Fire and EMS calls for December totaled 95 for a 2021 total of 1,123 calls which is an increase of 94 calls compared to last year. The 2021 call level was the highest level of calls ever recorded. During December 2021 there were 79 medical emergencies, 7 fires, and 9 vehicle accidents. Used 125.5.1 gal. diesel fuel and 136.7 gal of gas. (See Attachment #1).

<u>Treasurers Report</u> – Treasurer Bice gave the Treasurer's report. Bice reviewed all reconciled bank accounts as of 12/31/2021. All funds balance was \$3,651,320.59. The report included for the first time the new Fire Department Medicare savings account with County National Bank. (See Attachment #2).

<u>Police Report</u> – Police Chief Bancroft gave the Police report for the month of December, 2021. Hours worked were 521.5, miles driven 4,180 and 15 citations were issued. There were 9 auto crashes, and 127 Incident reports. Gas consumption was 377.1 gallons. Chief Bancroft updated the Board on the Jerome incident that required a Swat Team involvement and resulted in the incarceration of a Jerome male resident. (See Attachment #3).

Parks & Recreation — Treasurer Bice gave the Parks and Recreation report from the January 5, 2022 meeting. Bice said that Tyler LaBo was elected Chairperson replacing Terry Reister who became Vice Chairperson. Three new donation boxes for Mc Courtie Park were placed on order. Berm house windows and repairs were discussed. Committee working on transferring flag pole from Barnett Park to McCourtie Park. Concession stand being considered. Supervisor Shaw suggested that the Parks and Rec Committee reconsider the installation of vinyl windows in favor of preserving the existing windows that maintain the integrity of the historic nature of the park and follows Township purchasing Guidelines. <u>JCB</u> – Deloris Smith-Post gave the JCB report as of January 13, 2022. Combustion motor installed on upstairs furnace due to bearing failure Working on getting 3 bids for Generator. March 26th Craft Show spots are filling up fast. Considering the Craft Show to be an annual event. Volunteer hours 7 (See Attachment #5).

<u>Supervisors Report</u> – Supervisor Shaw updated the Board regarding ARPA funds and MTA annual meeting in Lansing, Michigan, scheduled for April, 2022.

Assessor's Report —Supervisor Shaw gave the Assessor report for January, 2022. All received documents are current and up to date on our active data base. Normal workload of paperwork and residents coming in to the office/phone calls. Anthony and Maribeth have completed a field inspection for all properties that have had a building permit pulled relevant to assessing functions. All of these inspections include an updated picture of improvements, a sketch that includes the physical dimensions of the improvements, and the % of completion as of 12-31-2021. Expenditures were 33% of the 2021/22 amended budget of \$3.0M. Burn rate for next 6 months is \$233K/month. Anticipated Revenues and Expenditures within 2021-22 budget of \$3,026K.
