AGENDA - Supervisor Shaw asked for any changes to the agenda: Shaw moved to add Board Discussion/ Decision to the Agenda before the second Public Comment. Second Meckley. Vote taken Ayes: 4. Nays: 0. Absent 1. Amended agenda approved

PUBLIC COMMENT: Opened at 11:03 AM. No citizens came forward to speak. Closed at 11:03PM.

Second Pumfrey. Roll Call vote taken with Ayes: Pumfrey, Meckley, Bohnet and Shaw. Nays: None. Absent Bice. Motion carried.
