THE LESSEE AGREES TO SO CONDUCT ITS ACTIVITIES UPON THE PREMISES SO AS NOT TO ENDANGER ANY PERSON LAWFULLY THEREON AND TO INDEMNIFY AND SAVE HARMLESS THE LESSOR AGAINST ANY AND ALL CLAIMS FOR INJURY TO PERSON OR PROPERTY (INCLUDING CLAIMS OF ELECTED AND APPOINTED OFFICIALS AND EMPLOYEES OF THE LESSEE OR ANY CONTRACTOR OR INVITEE) ARISING OUT OF THE ACTIVITIES CONTRACTED BY THE LESSEE, ITS AGENTS, MEMBERS OR GUESTS, OR INVITEES. IF LIQUOR IS SOLD DURING LESSEE'S USE OF THE PREMISES, LESSEE SHALL PROCURE APPROPRIATE LICENSES AND INSURANCE COVERAGE INSURING THE TOWNSHIP AND FURNISH LESSOR WITH COPY OF INSURANCE CONTRACT.
