If you are a new resident to Somerset Township and your home is your primary residence, make sure you file a Homeowners Principal Residence Exemption Affidavit with the assessor's office. This can save you a significant amount of money on your property taxes.

Another great link is the Property Tax Estimator. The links are easily available at your convenience, give them a try. ### Parks and Recreation Committee

Five new aluminum picnic tables have been added to McCourtie Park to replace some older wooden tables. Two older tables were placed at Barnett Field. Two barbecue grills were erected to replace rusted out pits and two new ones were placed, one at the ball diamond.

One tennis court was resurfaced with an all-weather Sports Deck this summer. The new surface was installed just before July 4<sup>th</sup>. It provides a surface that is void of cracks and makes for a more enjoyable game of tennis.

Work on installing a nine hole disc golf course in McCourtie Park has progressed this fall. Concern to not disrupt the natural beauty of the park and not interfere with the park's other activities has been a major factor in placing of the course. The present layout of the course will take advantage of unused areas in the park and only skirt the edges of the more popular areas.

Repair to the roof of the large Purple Martin House was completed this summer by the committee. Two new Purple Martin Houses have been purchased to be placed on existing posts in the park in the spring.

The Park Rental Agreement has been reworked and anyone wanting to reserve the park for a wedding, reunion or other function is encouraged to stop in to the Clerk's office to fill out a form.

Being on the Permanent AV list does not mean you automatically receive an Absentee Ballot for each election, it means the clerk's office has your permission to mail out the application to obtain an Absentee Ballot. An application must be filled out for each election in order to vote absentee ballot.
